**APPLICATION GUIDELINES 2010**

---

APPLICATION DEADLINE is ***TUESDAY, OCTOBER 12, 2010***  
***APPLICATIONS POSTMARKED AFTER DEADLINE WILL BE***  
***AUTOMATICALLY DISQUALIFIED***

- Students may receive a maximum of **FOUR** UFA Scholarship Fund awards. The annual number of scholarships available is dependent upon the amount of available funds. If applications exceed that amount, awards will be chosen by lottery.
- **PROOF OF ENROLLMENT** as of **FALL 2010 and full-time status (12 credits)**, in the form of a letter from the school confirming enrollment and credit load (*not letter of acceptance or class schedule*) **AND** copy of a paid tuition bill, **must be submitted along with application**. Applications missing either will be disqualified from consideration.
- **To avoid unnecessary delay and to ensure receipt of your application, please mail application and proof of enrollment by US POSTAL SERVICE RETURN RECEIPT**. Scholarship Fund staff cannot check to see if your application was received.
- **Faxed applications will not be accepted.**
- Each scholarship award will be in the amount of **\$500.00** and will be available once per year, not per semester.
- Award checks will be mailed to address provided on application, not to the school.
- Applicants must be currently enrolled in college, trade or vocational school (FULL-TIME) as of FALL Semester, 2010.
- High school students are ineligible for awards.
- **Dependent** children of active, retired or deceased Firefighters, Fire Marshals or Marine Wipers who are full-time students up to and including age 23; and Active UFA members and their spouses are eligible to apply for scholarship awards for UNDERGRADUATE EDUCATION.
- **Dependent** children and spouses of LOD deceased UFA members and dependent children of non-LOD deceased UFA members will receive automatic scholarship awards for UNDERGRADUATE EDUCATION, but **must** still fill out an application **and** provide required proof of enrollment (as above).
